## EXECUTIVE SUMMARY

This deliverable deals with the first SEAMLESS video, realized with the aim of outlining the concept of the project and the expected benefits from the implementation of the developed building blocks and enablers, relevant to autonomy in the maritime domain.

The video, one of two to be realized in the frame of project's lifetime, was produced and published in May 2024 to present the project not only to stakeholders, but to a wider audience as well.

The deliverable, originally scheduled for release in M6 (June 2023), was released in M17 to allow the inclusion of preliminary results achieved within the project into the video, such as the SEAMLESS Use Cases (Demo and Transferability) spanning Europe. 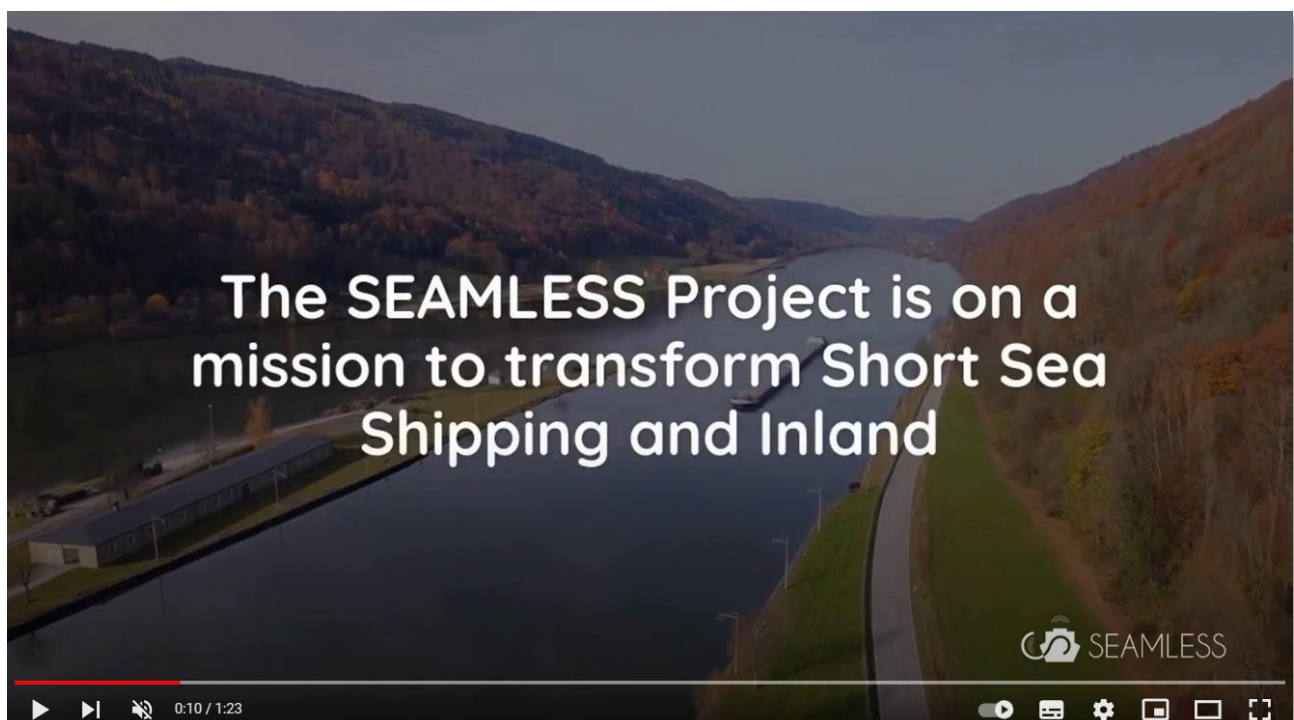


Figure 3: Video scene #2

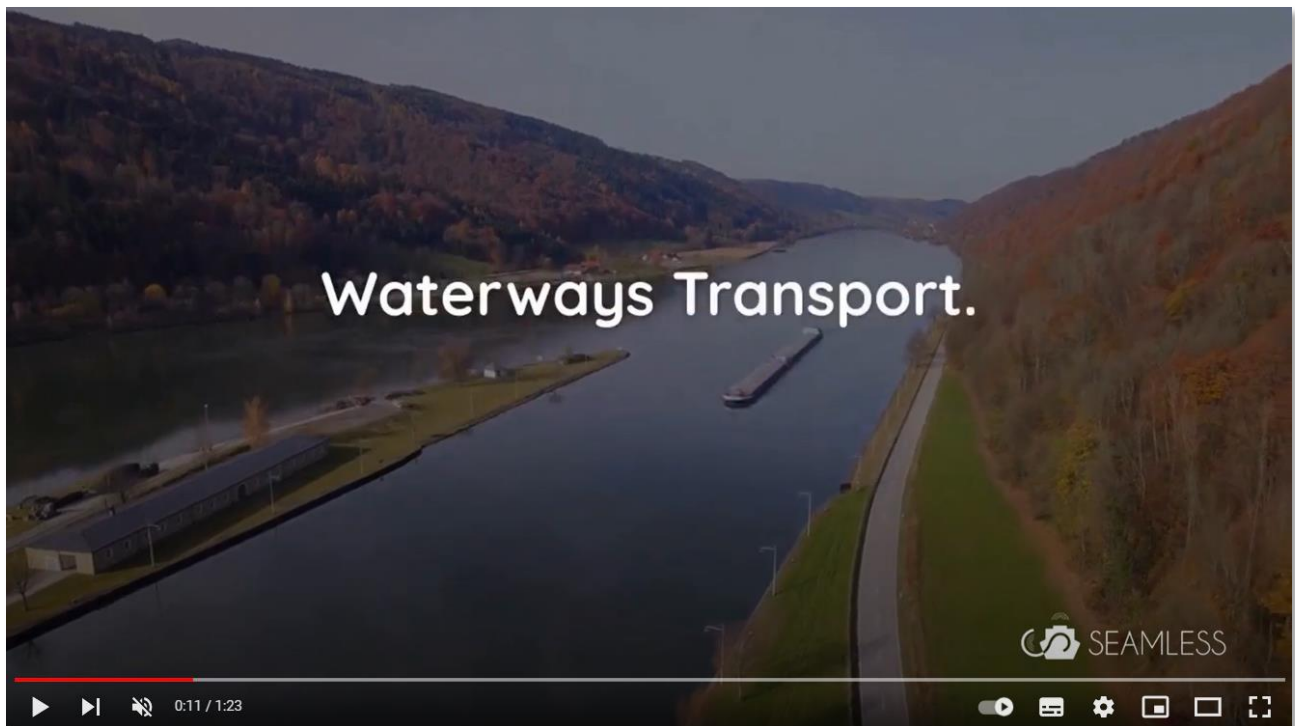


Figure 4: Video scene #3

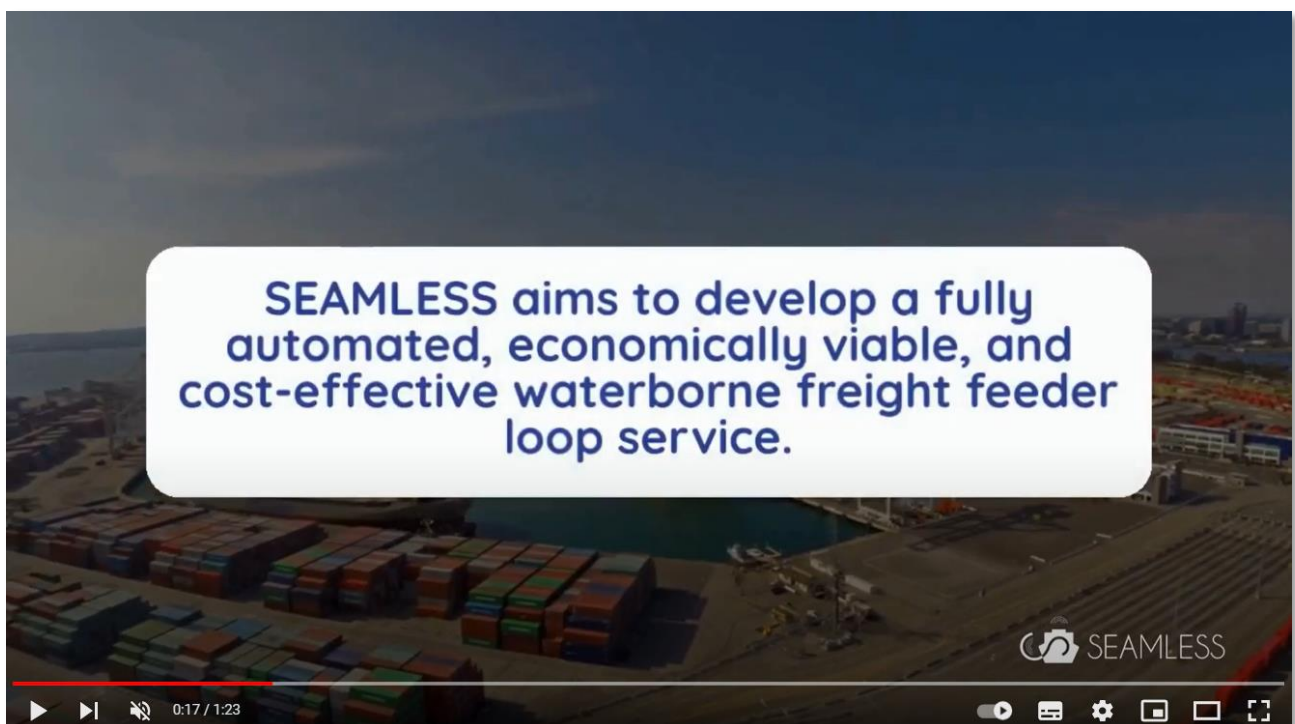


Figure 5: Video scene #4

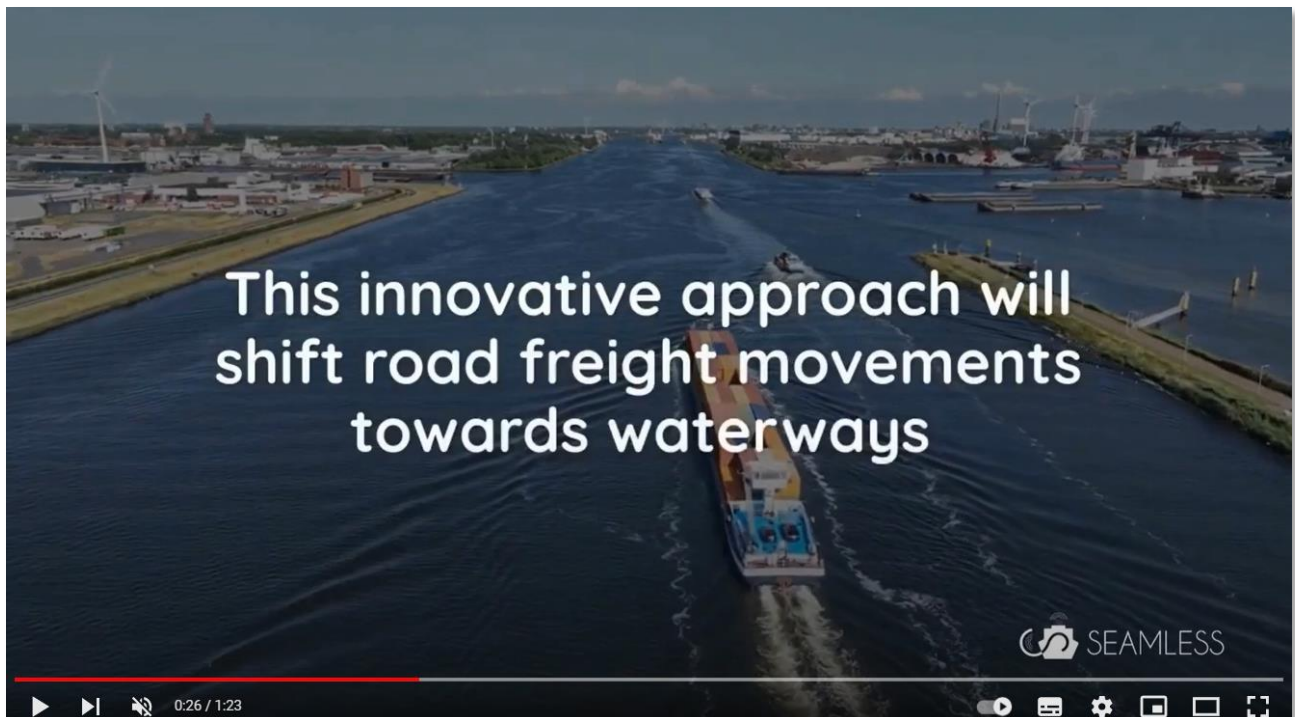


Figure 6: Video scene #5

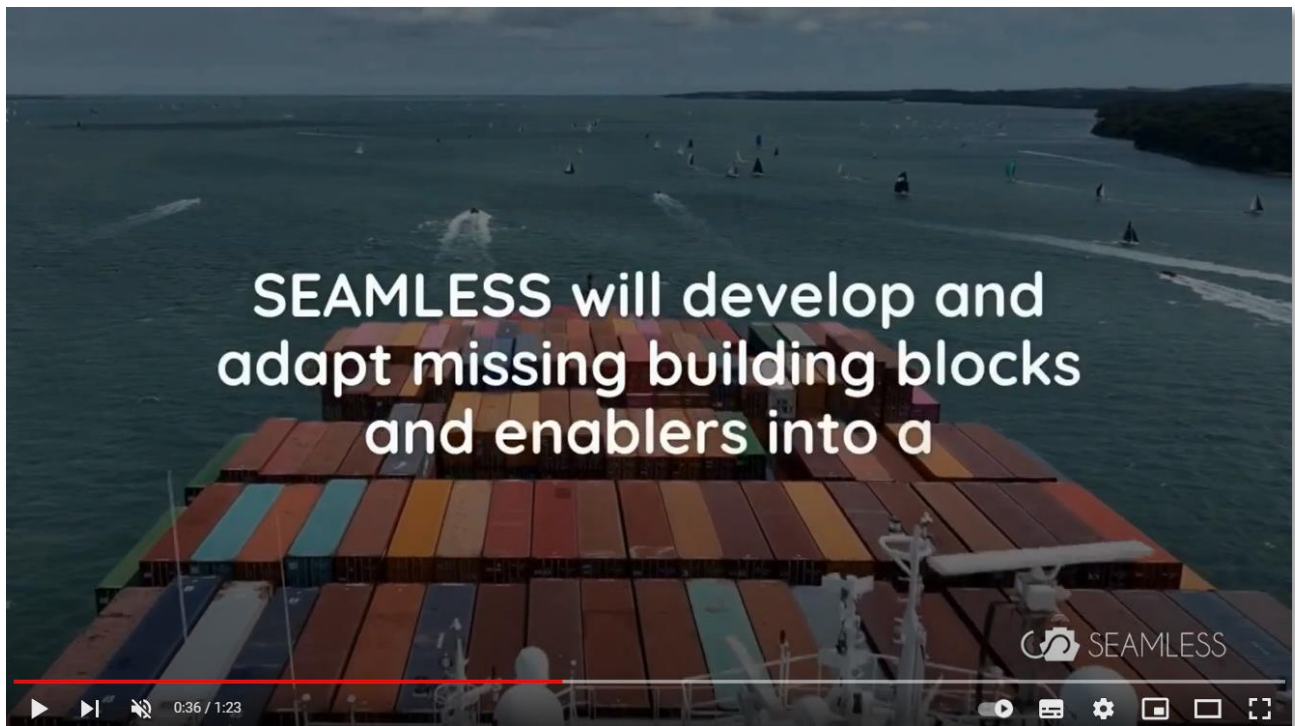


Figure 8: Video scene #7

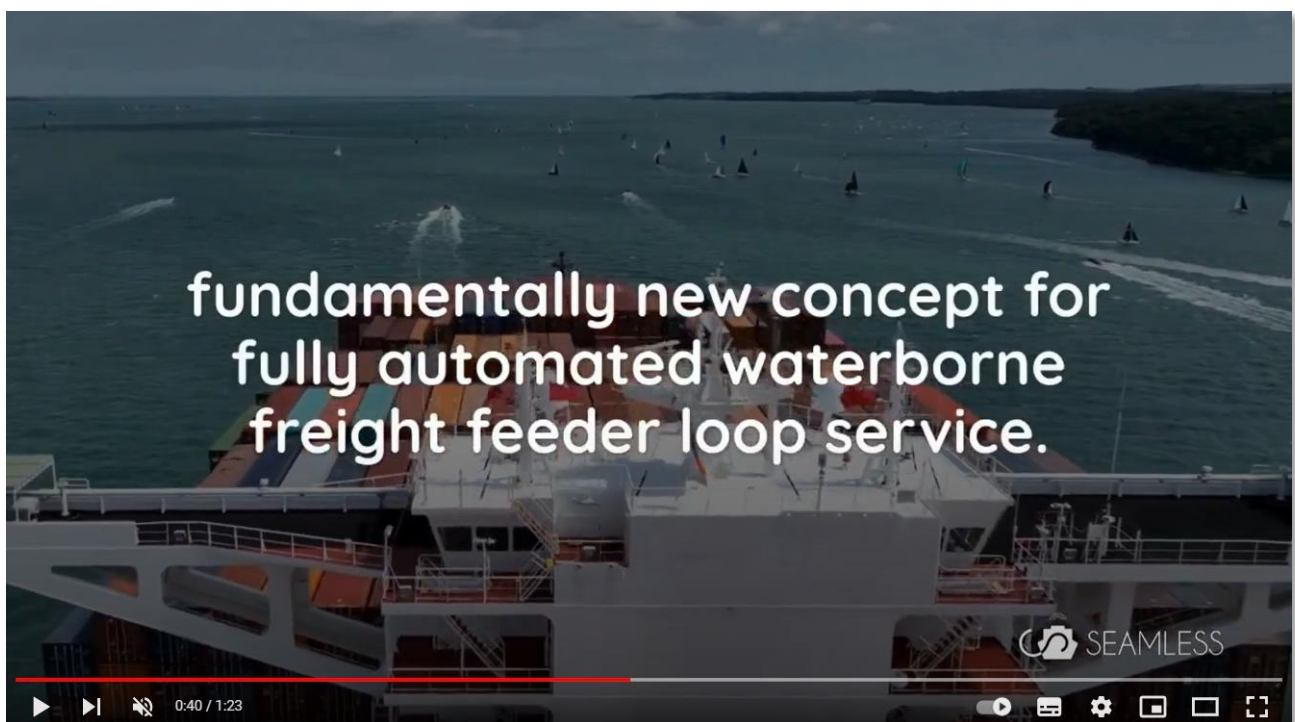


Figure 9: Video scene #8

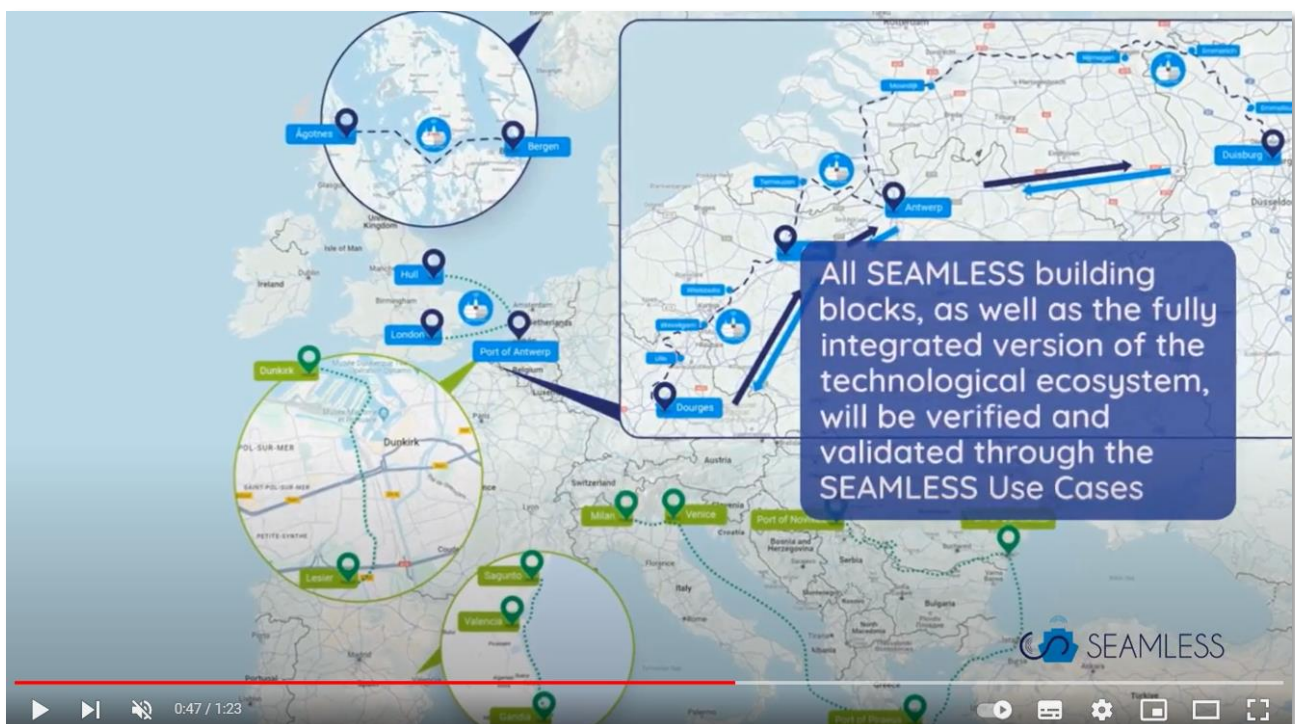


Figure 11: Video scene #10, focus on use cases

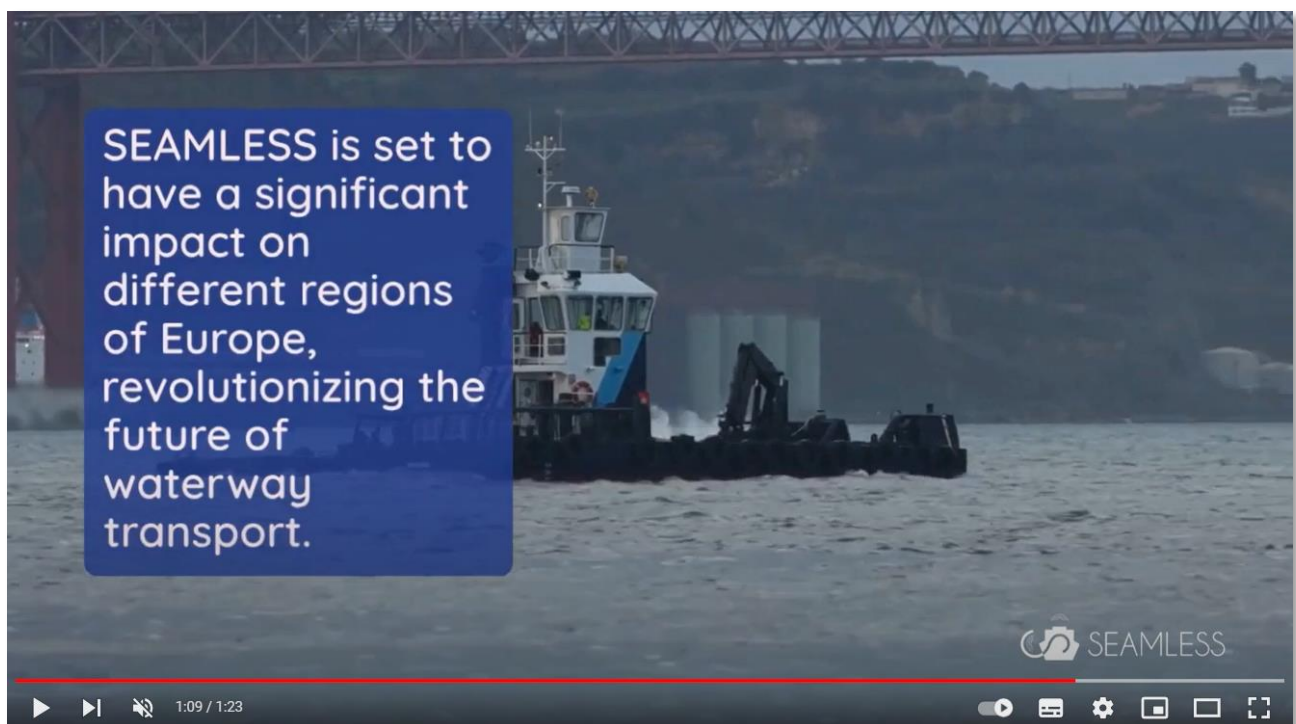


Figure 13: Video scene #12

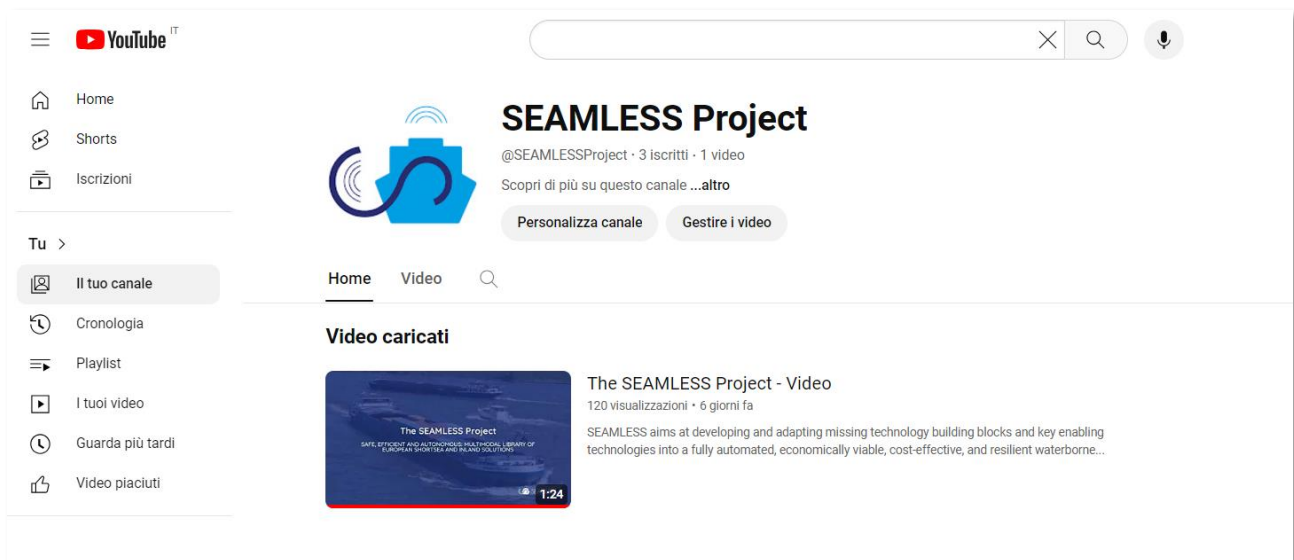


Figure 15: SEAMLESS channel on YouTube



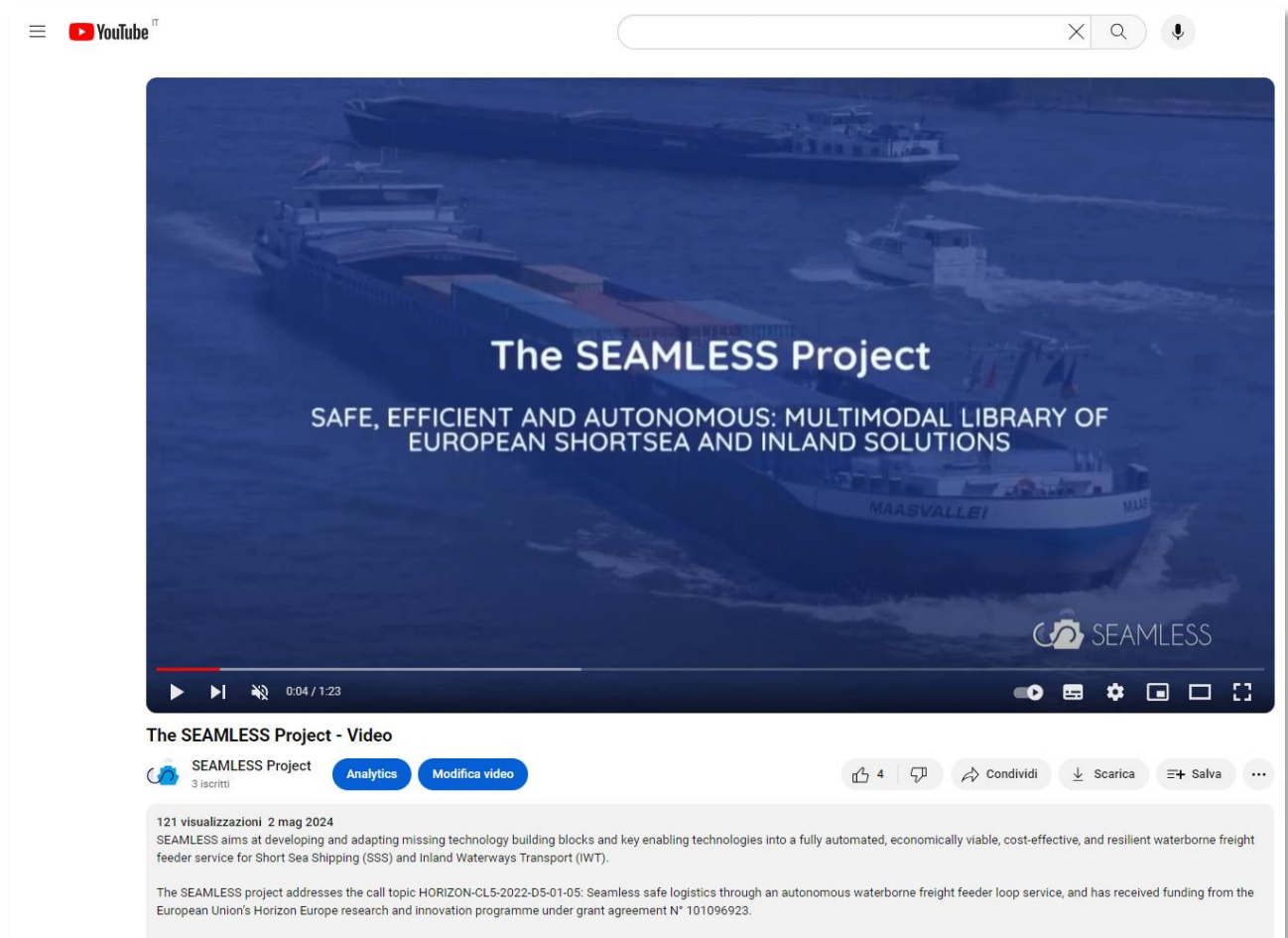


Figure 16: SEAMLESS video on YouTube

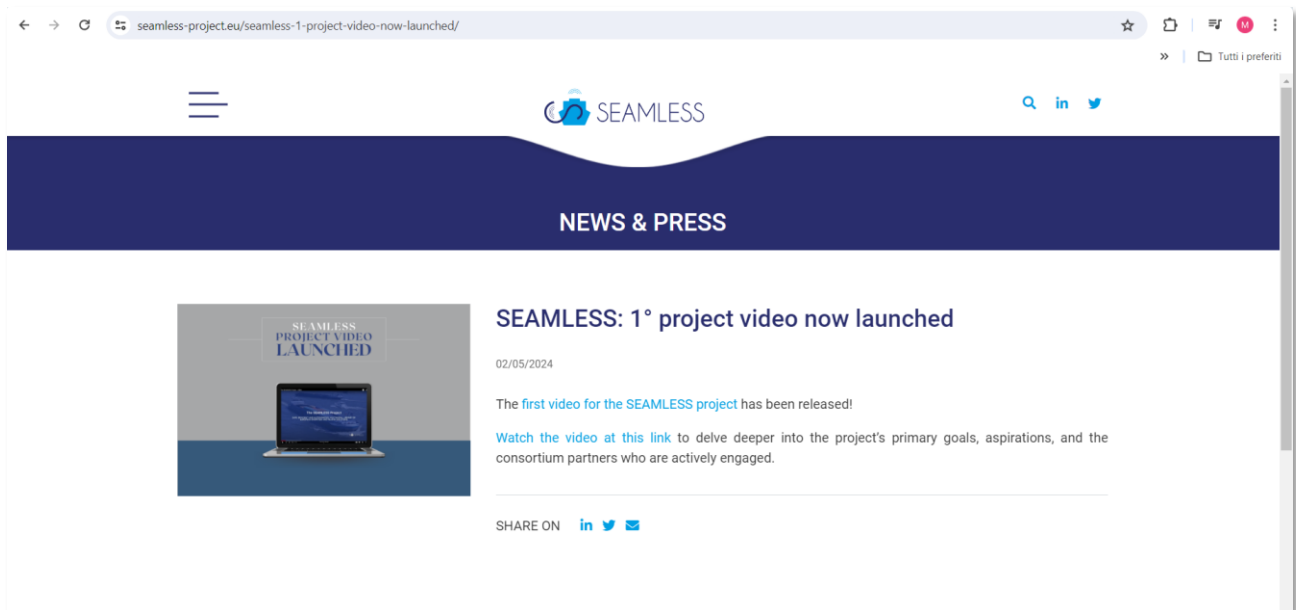


Figure 17: SEAMLESS video on project website
